## TOGETHER WE CAN FIND THEM!

Year after year there are 3,000 complaints of disappearances of children in Romania. 300 is the average number of children that remain unreachable at the end of each year. 1100 media messages were sent so far by Focus to find missing children. From its inception, Focus Center has provided 2000 hours of counseling to families of missing children.

### **2% CAN MAKE A DIFFERENCE!**

Directing 2% means help at finding a missing child, means that you revive joy to desperate families by helping to their reunification, it means that you return the smile on a child's face. **Without your help missing children don't come back!**

Through the 2% provision of the Tax Code, individual taxpayers have the opportunity to direct 2% of income tax to a nonprofit entity established under the Ordinance 26/2000 on associations and foundations.

### **HOW DOES IT WORK?**

For those who have incomes from wages, you should complete Form 230, "Request for destination amount of up to 2% of annual tax".

At section **DATA TAXPAYER'S IDENTIFICATION** fill your identification data (name, address, telephone number, personal identification number, etc.).

At section **DESTINATION AMOUNT OF UP TO 2% OF ANNUAL TAX FOR SPONSORSHIP OF A NON-PROFIT ENTITY, ACCORDING TO THE PROVISIONS OF ART.57 PARA. (4) OF LAW NO. 571/2003**, the amount doesn't need to be completed because it will be automatically calculated.

**PLEASE SEND COMPLETED FORM BY MAIL OR PERSONAL DEPOSIT IT TO THE FINANCIAL ADMINISTRATION WHERE YOU BELONG WITH YOUR RESIDENCE.**
